3. The first page of the manuscript should include the title of the paper, name of the author(s), organization affiliation, complete mailing address, phone number, fax no and the e-mail address.

4. An expert committee will screen the paper on the parameters like research content, originality and concept clarity.

5. Without Pre-registration, papers will not be included in the conference proceedings.

6. Tables, illustrations, charts figures etc. should be serially numbered and duly acknowledged. Sources of the data need to be given below each table.

7. Only those references that are actually utilized should be included in the reference list and the same should be alphabetically arranged.

8. Reference number will be given to all the accepted abstracts. For all future correspondence please quote reference number.
